What is verification?

Your Free Application for Federal Student Aid (FAFSA) was selected for “Verification” by the U.S. Department of Education. Verification is the confirmation through documentation that the information provided on your FAFSA is correct. The U.S. Department of Education requires colleges to verify the information reported by students and/or parent(s) on the FAFSA.

Instructions

- Complete all sections of this worksheet. Write “0” for any income not received and “N/A” for sections that do not apply.
- **Submit a copy of the 2017 IRS Tax Return Transcript, for you and your spouse (if married) or for your parent(s) (if dependent).**
- **Submit this completed form, along with the required financial documents to the address, or fax number listed at the top of the page.**
- Documents must be submitted within 14 days of the initial request to avoid a significant delay in processing and disbursing your financial aid to your student account. We will notify you if additional information is needed. This process takes 4 weeks to complete, so prompt attention to this request is essential for the timely processing of your financial aid.
